Preserve Plum Island Coalition: DO THIS for Plum Island...it's your most critical assignment yet

On Monday, September 23, the Senate Appropriations Homeland Security Subcommittee is scheduled to "markup" (process by which a U.S. congressional committee debates, amends, and rewrites proposed legislation) its 2020 budget bill, and consider legislation to protect Plum Island. We ask that you consider contacting your friends and colleagues and ask them to take action now.

We believe for the first time that there is a real possibility that legislation could move in the senate. Why? Because for the *first time the staff of both majority and minority members have been in the same room*-learning about and discussing ways that obstacles to Plum Island protection can be overcome. Just a few weeks ago, several members of our Coalition attended such a meeting in Washington, DC, and made our case.

We ask that you ask your constituents reach out to the leadership of the Senate Appropriations Homeland Security Subcommittee and Senate Appropriations Committee and ask them to include in their bill the same language that has already been approved by the House Appropriations Committeeto repeal the misguided law that impelled the Department of Homeland Security to plan to sell the entirety of Plum Island at public auction.

Letter to Senate Committees

Subject: Please help save Plum Island in the DHS appropriations bill

As you develop the 2020 appropriations bill for the Department of Homeland Security (DHS), I urge you to repeal a misguided, outdated mandate that was included in the 2009 and 2012 Congressional appropriations bills. This law resulted in DHS moving to sell Plum Island, an important island in Long Island Sound. We also ask that you to include language already approved by the House DHS committee that requires any future disposition of the island be only for the purposes of conservation, education, and research.

Plum Island is home to pristine beaches, diverse wildlife, and habitat for migratory birds, marine mammals, and rare plants, as well as cultural and nationally significant historical resources. The forced sale must be stopped and language that would ensure the long-term protection of the island must be included.

Members from both sides of Long Island Sound, both sides of the aisle, and both chambers have been working hard to repeal the language that puts this ecologically critical island in jeopardy. Saving this precious island is very important tome, and this legislation will safeguard against damaging development while encouraging conservation and retention of jobs.
